- **A.** Public Hearing FY 2022-2023 Proposed Budget: Fire Chief Martin opened the forum for public comment regarding the proposed budget. No comments were made. Mr. Ward made motion to open Public Hearing. Ms. Watson seconded. Motion passed Unanimously.
- **B.** Close Public Hearing: Mr. Ward made motion to close Public Hearing. Ms. Watson seconded. Motion passed unanimously.
- **C. Fiscal Year 2022—2023 Budget Adoption:** Fire Chief Martin requested the Board to approve the 2022-2023 Budget. Mr. Ward made motion to adopt the Proposed 2022-2023 Budget. Ms. Watson seconded. Motion passed unanimously.

ADMINISTRATIVE REPORTS

BC McShea: BC McShea reported a total of 178 calls in the last 30 days. We did 2 IFT's, 81 transports, and 30 non transports reported. We have provided Auto/Mutual Aid to FMFD on 12 calls, San Bernardino County on 6 calls, Golden Shores for 2 calls, and 1 for Oatman Fire.

Fire Marshal Gibson: Gibson reported that we received our permits today for the Radio Towers; we will begin to put them up at the beginning of July. Gibson announced that we were in the middled of transitioning to the new Dispatch Program which will be going Live next Tuesday. (June 21st)

Fire Chief Martin: Chief Martin briefed the Fireboard on some significant calls this past month and also provided a status of wildland fires that our Crews have been assigned to.

Chief Martin administered the Oath of Office to Firefighter Grayson Goodale.
