ADMINISTRATIVE REPORTS

BC McShea: BC McShea reported that we had a total of 222 calls in the last 30 days with a response time percentage of approximately 3 minutes. In the last 30 days we took 7 IFT's and turned down 36. Regarding Mutual Aid; We assisted Fort Mohave FD on 12 incidents, Sand Bernardino County on 6 incidents, Golden Shore on 2 incidents, and 1 incident in Oatman.

Fire Marshal Gibson: Fire Marshal Gibson provided an update to the Fireboard on the Avi Boat Ramp repairs; Estimated completion of the project is next week. Gibson briefed the Board regarding the Radio Towers.

Fire Chief Martin: Chief Martin informed the Fireboard that MVFD had two interviews for the Division Chief Position. Both candidates passed the process.

The Type 3 is still deployed in CA, expected to return on Friday, and possibly get sent right back out to California.
